Guest speakers	Biography		
Gary Sturgess	Gary has held the NSW Premier's ANZSOG (the Australia and New Zealand School of Government) Chair in Public Service Delivery at the University of New South Wales since 2011. He is also Adjunct Professor of Public Service Innovation at Griffith University in Brisbane, Australia. Gary was Cabinet Secretary in the New South Wales state government from 1988 to 1992 as well as a non-executive director of the global public service company, Serco Group plc. Between 2000 and 2011 he lived in London and headed the Serco Institute, a corporate think-tank funded by Serco which studied public service markets. In 2003, he helped to found the first industry association in the UK for the public services industry, serving as board adviser until his return to Australia in 2011. He has published extensively on commissioning, contestability and contracting of public services, and advised numerous government agencies and inquiries in Australia and New Zealand, the UK and Canada. The focus of his research and teaching since taking up the position with ANZSOG has been commissioning and contestability across a range of services. Since 2016, he had chaired the Commissioning and Contestability Advisory Board advising the NSW Minister for Corrections on the transformation of prison management. Among other things, the board oversaw the market-test of an existing remand facility, with an in-house bid. The tender was won by the in-house team and has been operated successfully by them for the past four years.

He takes a lead on the commercial aspects of the local authority practice specialising in complex procurement, shared services, PFI, outsourcing and public sector joint ventures. Outcome-based commissioning: a ten-step introduction Cohort 8

Why this learning programme?

Everyone is working hard to maximise the impact of their limited commissioning budgets. The need to make a real difference to citizens and outcomes has never been greater. Add to this the complexity of the system you work in, your limited resources and the pressure to act quickly and your challenge can often feel overwhelming.

This development programme has been designed to assist all those charged with deploying commissioning budgets to improve overall effectiveness, efficiency, and agility. It is an intense, introductory programme to outcomesbased commissioning designed to give you an overview and develop the way you work. It is complimentary to the PSTA's Commissioning Academy learning programme delivered on behalf of the Cabinet Office.

Introduction

The aim of this online and interactive learning programme is to enable you to grasp the core principles & practices of effective commissioning. By the end of the programme you will be better placed to help develop public services that make a really positive and lasting difference to local people's lives. You will also be able to act quickly with confidence using a commissioning mindset and call on your network of fellow participants for support and challenge.

The programme takes place over four mornings over a few weeks with space between each session to reflect and apply learning. Ahead of the first day we will provide a link to a 20-minute presentation on The Evolution of Commissioning by our colleague Stephen Moss. Participants are expected to have watched this before the first session. Each session starts with a check in at 9am and runs to 12.30pm with a couple of breaks. We will spend an hour to 90 minutes on each of the steps listed below. In addition, you will have time in small groups working as an action learning set (one which it is hoped will continue after the programme is over).

The dates for this cohort are to be confirmed, but will be late Spring / early Summer 2024. Sessions usually take place on Wednesday mornings between 9-12:30.





The programme

Please note that this is a learning programme, not a teaching programme. If you are looking for a series of lectures where your only initiative is to make a few notes, this is not the course for you. Instead, you will be asked to contribute (lots) and ask questions (lots), as well as doing some research and reading offline outside the three sessions. The more you put into your learning, the more you will learn and take away from this training.

The learning steps are:

- 1. What are we doing anyway?
- 2. What is commissioning?
- 3. Do we have to talk about leadership?
- 4. Are members of the public just customers?
- 5. How do we make the most of our resources?
- 6. Where does quality come into Commissioning?
- 7. Can we talk about procurement now?
- 8. Where do our values fit in?
- 9. How can we work best with our partners?
- 10. How can we design in creativity and innovation?
- 11. What now...?
